TERMS OF SERVICE

Welcome to the MyinTuition.org website (the “Site”). Please review these Site Terms of Service, which govern your use of the Site.

This Site is operated by MyinTuition Corp., a 501c3 organization ("MyinTuition", and also referred to in these Terms as "we", "us", "our", or similar terms). These Terms describe the conditions under which this Site is being made available to you, whether you are a visitor or a registered member or Provider (as defined below).
